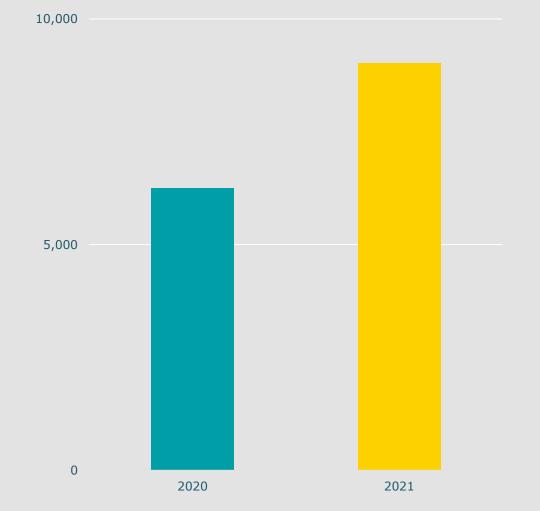








2021 1-9 Consolidated Revenue (NT\$M)
